



Opinion

We have audited the Standalone Financial Results for the quarter and year ended March 31, 2021, ("the statement") of Dolphin Medical Services Limited ("the company"), being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the statement:

(i) is presented in accordance with the requirements of the regulation 33 of SEBI {Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"),
